

The Corpus Christi People's Voting Guide is a publication of the Corpus Christi People's Assembly, published with the intent to provide the community with a new and different type of voting resource — one that asks specific, policy based questions of the city council candi-dates, relevant to the city's direct needs.

The Corpus Christi People's Assembly is a community-based coalition of non-partisan grassroots organizations working to develop a people's platform that will serve to empower and educate communities. Participating organizations include the Corpus Christi DSA, Participating organizations include the Corpus Christi DSA, For the Greater Good, The Nueces County Voter, and the Islander Feminists.

Below candidates were asked to respond to the questionnaire's statements with either Strongly Agree, Agree, Neutral, Disagree, or Strongly Disagree.

City Council- Mayor

Only 1 mayoral candidates responded to our questionnaire — John Wright.

Jim Klein: Our city should adopt a climate change action plan. We are on the front lines, already experiencing the effects of climate change in the form of increased coastal flooding in Flour Bluff, North Beach and elsewhere. We also are a major driver of climate change as the Port of Corpus Christi is the United States' leading oil and gas exporter.

Regarding the unhoused population, Corpus Christi should study actions taken by the city of Houston (building homes for the unhoused) and by San Antonio (creating service center for the unhoused where they can receive meals and wash) to determine if these approaches can work here. The City also should increase mental health services to further aid the unhoused.

Nancy Vera: *Candidate did not respond.*

Rachel Caballero: I would need additional information with regards to the questions I answered "Neutral" on. There are many issues that are complex and we shouldn't depend on the government to supply the solution.

Long-form question: Please summarize what you believe to be Corpus Christi's largest and most pressing issue(s) and your proposed solution(s).

Jim Klein: Corpus Christi's most pressing issue is that the city government acts in the interest of a few, often corporate, interests rather than acting for the common good. The City's reckless pursuit of desalination for the benefit of corporate investors is a prime example of this. The City's street repair contracts favor the contractors over area residents and businesses. These contracts should be rewritten to incentivize the timely completion of street repairs to put an end to projects that last three or more years.

To make city government more accessible to the public, City Council meetings should be moved to the evenings when working people can attend. Other cities of comparable size hold their council meetings after 5 pm. Corpus Christi should also.

Nancy Vera: Community Representation is Priority!

A Vote for Vera means...

- The representation and the voice of working families and city employees (collective bargaining) is paramount

- Prioritizing the environment: a clean city means clean air, clean drinking water, and clean bays for the future of our children

- Eliminating the giveaways to special corporate interests

We must increase the quality of life for all our citizens and not just line the pockets of the elite with greenbacks. We must stop the good-ol-boy giveaways and handouts. Giving billions of dollars in tax abatements for industry while taxpayers bear the [...]

brunt for industry's careless use of our precious water and polluting of our environment is abusive, negligent and unacceptable.

Rachel Caballero: Our budget is too large and spending is excessive. Do you see \$1.2B being spent in our city? Now we have a 2023 budget of \$1.4B? Where is all of this money going?

They are also asking for a 2022 bond of \$125M and they have to complete and start ANY of the projects from the 2020 bond. We must say no to bonds until the other bonds have been completed.
